#### Services

#### **Reviews and Revisions**

CLIENT will agree to the revision schedule articulated in the Statement of Work. With the agreement of both parties, the schedule may be adjusted as needed. Both parties will attempt to resolve any changes in the schedule made by outside vendors or unforeseeable acts. CLIENT will agree to use the same word processing software (e.g. Microsoft Word with Track Changes, Google Docs with Suggestions, etc.) throughout the revision process to avoid discrepancies encountered when converting documents to different file types.

## Acceptance of Deliverables

CLIENT will review, approve, and accept final work in the format stated in the Statement of Work. Revisions after acceptance of deliverables is subject to a new work agreement.

## Confidentiality

Ashli will maintain the highest level of confidentiality regarding the project. All proprietary information will remain confidential. Ashli may request references or testimonials.

#### **Termination**

Either party may terminate this contract if terms are violated with written notice. In the case of non-performance by either party, the opposing party may terminate this contract with five day written notice.

## **Manuscript Reader** (most common for graduate students)
